This document does not reflect the following change in the 2007 income eligibility limits for the Property Tax Reimbursement Program:

Legislation approved in December 2008 (P.L. 2008, c.119) increased the income eligibility limits for 2007 from less than \$45,135 for single applicants and less than \$55,344 (combined income) for married/civil union couples to \$60,000 or less for all applicants. The new income limit applies regardless of marital/civil union status. However, applicants who are married or in a civil union must report combined income of both spouses/civil union partners.

Receiving Federal Social Security Disability Benefits. If you (or your spouse/CU partner) were under 65 and indicated at Lines 4a and/or 4b that you (or your spouse/CU partner) were receiving Federal Social Security Disability Benefits, you must submit with your application a copy of the Social Security Award Letter indicating that you (or your spouse/CU partner) were receiving benefits for that year(s) based on your own social security number.
